Shag Notes

Shag Notes is a monthly music comment column. Opinions are those of the author alone and not of the Roanoke Valley Shag Club.

As some of you know, Fall SOS was a time where the weather cooperated wonderfully and the live music flowed on Ocean Drive. Although the number of dance floors declined with the closing of the Boulevard Grill, the remaining clubs were packed. New music releases always accompany SOS, and I was in Judy's House of Oldies on the Wednesday before SOS when the KHP compilation release **You Bug Me Baby** was unpacked. I bought the first copy through Judy's.

You Bug Me Baby follows the established KHP format of providing a good range of currently popular beach & shag music. This disc has 15 songs, and most are from artists that you will recognize. The collection opens with "Your Sweet Love" from the Holiday Band, which they performed live on the opening Friday of SOS. Rhonda McDaniel and Mike Taylor sing the title track, which was previously released by Delbert McClinton and Francene Reed (and likely others prior to that). Paul Craver offers a "smoothie" with his version of "Love Is A Many Splendored Thing". Other recognizable names include the Magnificents, the Castaways, William Bell, and the Entertainers.

Two country cross-over songs were likely the most popular ones of Fall SOS this year, and if you hesitate about buying the country album by Josh Turner for the one song "Why Don't We Just Dance", check out Glenn Tippett's version on this KHP compilation. You know Glenn as Coastline's talented saxophone and keyboard artist that is always being teased by Jim Quick about his stature. There is no shortage to his deep bass voice, and he provides a very credible version of "Why Don't We Just Dance".

All fifteen songs on this CD are "danceable". For me, Vicki Skinner's "Who Do You Love" is a weak link as she doesn't show the vocal range that the song requires. While there doesn't appear to be any shag dance "blockbusters" on this disc, **You Bug Me Baby** is a very competent compilation that will remind you of the current play list of 94.9 The Surf FM radio.

What have you done this past month to support the musicians? Music: Buy it, don't burn it.

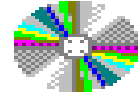
